DISCUSSION & DELIBERATION – ALL

1. Revised approach to regulating Alcohol Beverage License in Old Downtown District

City Planner Murriah Dekle and Interim Development Director Terry O'Neil gave a brief overview regarding the proposed regulation of Alcoholic beverage License in the downtown.

Murriah further explained how a new establishment would be able to come into the downtown, if adopted at the 13%.

She said the boards could increase the numbers if they felt the need for it or leave as is. If you decide to leave it where it is, someone would have to come in an add additional square footage to the downtown district, in order to maintain that ratio. By basically adding new floor area to the old downtown district. Example: If 19,230 square feet of space is built, 2,500 square feet or 13% of the space maybe license as an COP establishment. If an existing COP space is vacated or remains vacant for more than 90 days, without the owner or tenant obtaining a renovation permit, or a new COP license at that location.

Several items were discussed between the three boards regarding the following:

- Include Ancillary outdoor seating into calculations.
- The addition of second and third floors to existing one story buildings.
- Parking Garage and how would affect new businesses and their parking requirements.
- The exception and formula process to the existing businesses.
- Look at mechanism to attract people to the downtown and create a fair means to make the extra space to be made available.

2. Presentation Downtown Stuart Parking Master Plan

Teresa Lamar Sarno gave a brief introduction for the Downtown Parking Master Plan and introduced Curt Easton of IBI Group presenting their final report of the downtown parking study.

Curt Easton: Gave a visual presentation to the Commission/Boards regarding the inventory and supply of the existing parking in the downtown. He explained the process used to determine needs and demand, and if it would be valid to construct a parking structure. (The final parking study report is available in the Office of the City Clerk).

The final report will be accepted into the record.

City Manager Hudson mentioned the upcoming Amtrak Meeting to be held on March 26, 2010, at 10:00 am at Cocoa City Hall in Cocoa. He invited all and encouraged attendance.
