RESOLUTION NUMBER 116-09

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF STUART, FLORIDA ADOPTING THE FINAL BUDGET OF THE CITY OF STUART, FLORIDA, FOR FISCAL YEAR BEGINNING OCTOBER 1, 2009 AND ENDING SEPTEMBER 30, 2010; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES..

WHEREAS, it is necessary and proper, and in some instances required by Florida law, to establish the budgetary spending plans (annual budgets) for the various funds of the City of Stuart for the fiscal year beginning October 1, 2009, and ending September 30, 2010, in order to properly reflect anticipated revenues and required appropriations.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF STUART, FLORIDA that:

SECTION 1: The City of Stuart, Florida hereby adopts the final budget, attached hereto, for the fiscal year beginning October 1, 2009 and ending September 30, 2010, as follows:

(a) There is hereby appropriated from the GENERAL FUND of the City of Stuart for the above described fiscal year, the total sum of Twenty One Million Seven Hundred Ninety Nine Thousand Three Hundred Ninety-Eight (\$21,799,398) Dollars to provide for the annual budget of the General Fund.

- (b) There is hereby appropriated from the LANDFILL CLOSURE TRUST FUND of the City of Stuart for the above described fiscal year the total sum of Fifty Four Thousand, Nine Hundred, Seventy One (\$54,971) Dollars to provide for the annual budget of the Landfill Closure Trust Fund.
- (c) There is hereby appropriated from the COMMUNITY REDEVELOPMENT AGENCY of the City of Stuart for the above described fiscal year the total sum of Two Million Five Hundred Seventy Four Thousand Six Hundred Seventy-Seven (\$2,574,677) Dollars to provide for the annual budget of the Community Redevelopment Agency Fund.
- (d) There is hereby appropriated from the PROPERTY MANAGEMENT FUND of the City of Stuart for the above described fiscal year the total sum Seven Hundred Five Thousand Eight Hundred Thirty-Four (\$705,834) Dollars to provide for the annual budget of the Property Management Fund.
- (e) There is hereby appropriated from the WATER AND SEWER FUND of the City of Stuart for the above described fiscal year the total sum of Eight Million Five Hundred Fifty Two Thousand Two Hundred Seventy-One (\$8,552,271) Dollars to provide for the annual budget of the Water and Sewer Fund.
- (f) There is hereby appropriated from the SANITATION FUND of the City of Stuart for the above described fiscal year the total sum of Three Million Nine Hundred Seventy Two Thousand Two Hundred Forty-Six (\$3,972,246) Dollars to provide for the annual budget of the Sanitation Fund.
- (g) There is hereby appropriated from the STORMWATER FUND of the City of Stuart for the above described fiscal year the total sum of Five Hundred Eighty Seven Thousand Three Hundred Sixty-Four (\$587,364) Dollars to provide for the annual budget of the Stormwater Fund.
- (h) There is hereby appropriated from the COMMUNITY DEVELOPMENT BLOCK GRANT FUND of the City of Stuart for the above described fiscal year the total sum of One Million (\$1,000,000) Dollars to provide for the annual budget of the Community Development Block Grant Fund.

SECTION 2: This Resolution shall be effective immediately upon adoption.


