Mayor Clarke welcomed Jacqui Thurlow Lippish She also gave one of her now famous "shout outs" to staff member Carly Audry of the Community Development Department for working hard on the LDRs. She also requested that staff address noise issues. Yesterday the Mayor visited a Stuart company known as Eco-Sphere that is now educating elected officials on the use of oxygen to purify our water. Addressing the Resolution on Eminent Domain, the Mayor noted that she had received some negative comment and requested that Consent Item 10 be pulled for discussion. She then turned her attention to foreclosure proceedings on the Lakeside Apartments on MLK Blvd. which will result in leaving a number of elderly and low income people homeless. She noted that the USDA mortgage holder will sponsor a public hearing at the Blake Library on September 24th and asked staff to arrange for public transportation to help those being displaced to get to the meeting.
